#### **Emissions Reduction Targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 369.52 tCO2e by 2027. This is a reduction of 23%

## **Carbon Reduction Projects**

The following environmental management measures and initiatives have already been initiated:

- Reduced business travel through increased home-working and company-wide usage of remote meeting technology
- Reduced paper consumption by implementation of digitial signature technology

The impact of the above initatiatives will be measured during our next assessment.

We plan to implement further measures which will continue to drive down emissions. We are considering several initiatives and those listed below are examples of areas we are discussing and the potential impact they may have to our emissions.
